- (b) Reconstruction or repair shall be compulsory and where the insurance indemnity is insufficient to cover the cost of reconstruction and reconstruction is required as provided for herein and in the Act, the building or reconstruction costs in excess of the insurance . proceeds shall be paid by all apartment owners directly affected by the damage. If reconstruction or repair is not undertaken within six months, the council of co-owners may give written notice to the apartment owner that unless within thirty days such reconstruction or repair is undertaken, then the apartment owner shall relinquish all rights and ownership of land and improvements in The Green. Such ownership will revert to the council of co-owners. Upon the filing of an affidavit by the council of co-owners in the Clerk's Office of the Circuit Court of Lancaster County, Virginia, that notice has been given as aforesaid and that the owner has defaulted whereby the council of co-owners has become the owner by reversion of such apartment, any person shall be entitled to rely upon such affidavit as a muniment of title.
